

Terms & Conditions – Jet2holidays ‘Bid for a Break’ March 2026

This promotion is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays" or "we"). By entering a promotion, you are deemed to accept these terms:

1. Bid For a Break myJet2 will run for a week from the 23rd March 2026 to the 30th March 2026. The promotion will start at 10.00am on 23rd March 2026 (the starting date) and close at 10:00am on 30th March 2026 (the closing date).
2. Entrants to a promotion must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited, Jet2 plc or any companies within the same group or any organisation professionally involved with a promotion (or in each case, their close relatives) are not eligible to enter.
3. An entrant may only enter each promotion once. If you enter a promotion more than once, all entries will be removed.

How to enter:

4. To enter a promotion for an opportunity to purchase a holiday at a lowest unique bid price, you must go on the Jet2 app between the times detailed in paragraph 1 above and follow the directions to the entry page of "Bid for a Break", where you must then complete the relevant form, entering the price you think will be the lowest unique bid for the holiday displayed and as detailed within these terms.
5. Jet2holidays shall not be responsible for and shall not have to accept entries which do not reach it before the closing date or are illegible, incomplete or corrupted, or cannot be submitted for any reason. You must have a valid email address to participate in the promotion.

Choosing a Winner:

6. There will be one winner of the promotion. The winner of the promotion will be either (i) the person who has entered the lowest unique bid for the advertised holiday in that promotion; or (ii), in the unlikely event of there being no lowest unique bid, Jet2holidays will take the price that has been entered by the lowest number of people and randomly select a winner from those entrants who have entered that price. Where there are two or more prices with jointly the lowest number of entrants who have bid on the respective amounts, the winner will be randomly selected from the entrants who submitted the lowest of those prices.
7. The winner will be notified by email or using the other contact details provided to us within 48 hours after the closing time for the relevant promotion. We will try our best to contact the winner during the specified time.
8. Once contact has been made with the winner, they will be offered the chance to purchase the holiday that was the subject of the particular promotion they have won and they will be required to confirm whether they would like to purchase that holiday at the price of their winning bid or not, within 48 hours of having been notified of their win. The winner is under no obligation to purchase the holiday.
9. If the winner does confirm that they would like to purchase the holiday at the winning price, Jet2holidays will take the winner through its holiday booking process, which will be subject to Jet2holidays' and Jet2.com's terms and conditions which can be found at <http://www.jet2holidays.com/terms-and-conditions> and <http://www.jet2.com/terms> respectively (together, the "Terms and Conditions").
10. If the winner (i) cannot be contacted or is not available; (ii) has not confirmed whether or not they would like to purchase the holiday at the winning price within 48 hours of having been notified of their win; or (iii) does not want to purchase the holiday at the winning price, then the winner will forfeit their prize and will no longer be entitled to purchase the holiday at the winning price. If this happens, Jet2holidays can select another winner using the same selection criteria described above.
11. For transparency we will generally publish the first name, first letter of surname and county of prize winners online. However, if you are a winner and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize.

The Prizes:

12. The prize for the promotion commencing on Monday 23rd March 2026 at 10:00am until Monday 30th March 2026 10:00am is the opportunity to purchase the following holiday at the winning bid price:
 - i. A 7-night holiday on an all-inclusive basis in a suite at the 4* plus Mediterranean Palace
 - ii. in Tenerife, Canaries for 2 adults (over the age of 18 at the date of departure) and 2 children (up to age 12 on the date of return).
 - iii. The holiday includes return flights from any UK Airport from which Jet2.com flies to Tenerife (South) Airport (TFS) and allows for the duration of the prize advertised, transfers to and from the overseas airport and the hotel AND 1 free item of checked baggage of up to 22kg per person.

14. If the holiday is purchased it will be subject to the Terms and Conditions, the Package Travel and Linked Travel Arrangements Regulations 2018 and any other applicable law. If the winner wishes to add any extras to the holiday as it is stated above, this must be done after the initial booking and any such amendment will also be subject to the Terms and Conditions, the Package Travel and Linked Travel Arrangements Regulations 2018 and any other applicable law.
15. Holidays are subject to availability. Upon booking their holiday, the winner will be required to select their preferred travel dates subject to any restrictions referred to in the applicable prize details above and Jet2holidays will endeavour to meet the winner's request, taking into account flight and hotel availability, Jet2holidays' and any applicable hotelier's operation and any other relevant factors which may affect availability.

17. All passengers must have a valid passport to travel, and must meet all relevant visa and/or other entry requirements including any medical/health screening requirements or similar.

General:

18. Entrants' details will be used to administer the promotion and winner's details will be used to provide the holiday (where they do wish to purchase the holiday at the winning bid price). If entrants choose to opt in, their details will be retained by Jet2holidays for the purposes of marketing (which may include activities such as passing on information about deals, offers and promotion codes from Jet2holidays).
20. Jet2holidays may in its absolute discretion change these terms and conditions without prior notice at its discretion.
