

## Terms & Conditions – myJet2Perks x Aquaplanet Prize Draw

This prize draw is promoted by Jet2.com Limited (registered number: 02739537) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2.com", "Jet2" "us" or "we"). By entering this prize draw, you are deemed to accept these terms.

1. This prize draw opens at 09:00am on 30<sup>th</sup> April 2026 and closes at 11:59pm on 18<sup>th</sup> May 2026.
2. Entrants to this prize draw must be myJet2 members logged into myJet2 on the Jet2 app, residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays Limited, Jet2.com Limited, Jet2 plc, employees and officers of Aquaplanet or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter. An entrant may only be entered into the prize draw once.

### How to enter:

3. Jet2 will host a landing page in the Jet2 app.
4. To enter this prize draw you must log onto myJet2 within the Jet2 app and click to enter the prize draw by following the relevant URL and enter your details before the closing time and date detailed in paragraph 1 above.
5. Jet2 shall not be responsible for and shall not have to accept entries which do not reach it before the closing time or are illegible, incomplete or corrupted.

### Choosing a Winner:

If a winner cannot be contacted or is not available, we reserve the right to select another winner from the valid/correct entries that were received.

If a winner has not claimed their prize by the date specified, we reserve the right to select another winner from the valid/correct entries that were received. Winners must have a valid email address to claim their prize.

Insofar as permitted by law, Jet2 will not accept any liability for or arising from the prizes.
14. If a prize is not accepted by the applicable date, it will be deemed forfeited and Jet2 reserves the right to award a prize to another randomly selected entry.
15. Jet2 reserves the right (but shall be under no obligation) to substitute the prize or any element of the prize with an alternative at any time to the equivalent prize value or at its discretion, the cash value of the prize or element of the prize being substituted.
16. The prize and each element of the prize is non-transferable and may not be exchanged for cash.
17. No element of the prize may be changed by the winner.

#### The Discount:

The Company will provide a generic discount code for £30 off any Aqua Planet paddle board.

#### Discount Terms

The discount code is available for all entrants. The code will be displayed on the prize draw confirmation page and will discount all paddle boards by £30. Discount can be applied to all paddleboards, including full price and sale paddle boards. Entrants should add the code to the checkout to be active. The code will be valid until 23:59 31<sup>st</sup> May 2026. Code cannot be used in conjunction with any other discount code.

#### General Terms:

18. Entrants’ details will be used to administer the prize draw and Jet2 will pass the winners’ details to the prize provider for fulfilment of the prize. 20. Jet2 may in its absolute discretion change these terms and conditions or extend the prize draw without notice at any time. Jet2 may cancel a prize draw without prior notice in the event of circumstances arising beyond its control.
21. Where Jet2 makes any changes to the prize, no compensation or cash equivalent will be available. Jet2 will not be liable for any cancellations or changes to the prize draw or any prize, or for any loss

or damage. Nothing in these terms shall exclude or limit the liability of Jet2 in relation to personal injury or death caused by Jet2 negligence or for fraud.
