

Terms & Conditions – VIBE by Jet2holidays x Ibiza Rocks Content Prize Draw

This prize draw is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays", "we" or "us"). By entering the prize draw, you are deemed to accept these terms:

1. This prize draw opens at 10:00 on 14th July 2025 and closes at 23:59 on 1st October 2025.
2. Entrants to this prize draw must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited ("Jet2.com"), Jet2 plc or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter.

How to enter:

3. The social media account must post Ibiza holiday content on Instagram or TikTok and include a tag of **@jet2vibe** in the post. Multiple entries are permitted.
4. To enter this prize draw you must post the Ibiza holiday content on Instagram or TikTok and tag **@jet2vibe** before the closing time and date detailed in paragraph 1 above.
5. Jet2holidays shall not be responsible for and shall not have to accept entries which do not reach it before the closing time or are illegible, incomplete or corrupted.

Choosing a Winner:

6. There will be 1 lucky winner of the prize draw.
7. A shortlist of the best entries will be picked, and a Jet2holidays panel and independent judge will pick 1 winning entry from the shortlist based on a subjective interpretation of the entrant's entry. The judge's decision is final and no correspondence will be entered into.

9. The winner of the prize draw will be notified by a comment or direct message on the social media account that they entered the prize draw with within 7 days after the closing time for the prize draw. We will try our best to contact the winner during the specified time. If a winner cannot be contacted or is not available, we reserve the right to select another winner from the valid/correct entries that were received.
10. The winner will be required to confirm acceptance of their prize within 5 days of having been notified. If a winner has not claimed their prize by the date specified, we reserve the right to select another winner from the valid/correct entries that were received. Winners must have a valid email address to claim their prize.
11. For transparency we will generally publish the surname and county of prize winners online. However, if you are a winner and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize.

The Prize:

12. One (1) lucky winner will win a Jet2holidays voucher to the value of £500 ("the **Prize**"). Please note, it must be used by the winner on a new Jet2holidays booking, which for the avoidance of doubt includes standard Jet2holidays, Indulgent Escapes, Jet2Villas, VIBE and/or CityBreaks holidays. It cannot be used for an existing booking.
13. The Winner may book more than one holiday using the voucher but if doing so, the holiday bookings must be made at the same time and can total more than the Prize but the difference in value must be paid at the same time. The voucher must be redeemed by 31st March 2026 and all travel must be completed by 31st December 2026. Booking must be made via the Jet2holidays contact centre.
14. Such holiday shall not constitute a 'package' under the Package Travel and Linked Travel Arrangements Regulations 2018 (the "**Regulations**") and the Regulations shall not apply, nor shall the applicable provisions of the Terms and Conditions which relate to the Regulations. Where the holiday booked using the Prize exceeds the value of the voucher it shall be subject to the Terms and Conditions. In the event of any conflict between the Terms and Conditions and the Promotion terms and conditions, the Promotion terms and conditions will take precedence.

Jet2holidays reserves the right to amend or cancel the flights or holiday for any reason without prior notice (which may include substituting the prize or any element of the prize with alternative dates/property/transfers/destinations at any time, to the equivalent prize value). Please note that the Jet2.com flight schedules are not guaranteed.
21. The Prize is non-transferable and may not be exchanged for cash. The Winner has no right to request or receive an alternative to the Prize, and the Prize cannot be redeemed for cash or its monetary value, in whole or in part.
22. If the total cost of the holiday that the winner selects totals less than voucher amount, the winner shall not be entitled to the difference and that additional amount shall be forfeited. If the winner would like to choose a holiday which totals more than the voucher amount, they shall be responsible for paying the difference in cost.
23. The holiday booked using the Prize may only be taken by the prize draw winner along with any accompanying passenger(s) notified to Jet2holidays in the relevant booking. Flights must be taken by all

passengers at the same time from the same airport. Once you have made your booking this cannot be amended.

General:

By tagging **@jet2vibe** in a post on Instagram or TikTok, the user grants Jet2holidays a non-exclusive, royalty-free, worldwide, perpetual licence to use, repost, share, publish, and otherwise utilise the content — including the associated social media account's username, caption, and any imagery or video — across **@jet2vibe**'s social media channels and digital platforms for promotional and marketing purposes.

By tagging **@jet2vibe**, the user confirms that:

They are the original creator of the content or have obtained all necessary rights and permissions to allow its use as described.

No third-party rights, including copyright, moral rights, or rights of publicity or privacy, will be infringed as a result of Jet2Vibe's use of the content.

The user is at least 18 years of age, or has obtained parental or guardian consent if under 18.

29. Jet2holidays may in its absolute discretion change these terms and conditions or extend the prize draw without notice at any time. Jet2holidays may cancel a prize draw without prior notice in the event of circumstances arising beyond its control.
30. Where Jet2holidays makes any changes to the prize (including dates of travel), no compensation or cash equivalent will be available. Jet2holidays will not be liable for any cancellations or changes to the prize draw or any prize, or for any loss or damage entrants or accompanying passengers suffer as a result of entering the prize draw provided that nothing in these terms shall exclude or limit the liability of Jet2holidays in relation to personal injury or death caused by Jet2holidays negligence or for fraud.
