

Annex 1 – Terms & Conditions: Jet2holidays x Pan Macmillan – Prize Draw 1: Social Media Prize Draw

This prize draw is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays") and Macmillan Publishers International Limited (trading as Macmillan Children's Books which is an imprint of Pan Macmillan), registered number 02063302, whose registered office is at Cromwell Place, Hampshire International Business Park, Lime Tree Way, Basingstoke, Hampshire, RG24 8YJ ("the Company", and together with Jet2holidays, "the Promoters"). By entering the prize draw, you are deemed to accept these terms:

1. This prize draw opens at 09:00 on 20th July 2026 and closes at 23:59 on 26th July 2026.
2. Entrants to this prize draw must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited ("Jet2.com"), Jet2 plc Macmillan Publishers International Limited (trading as Pan Macmillan), Mostra agency or any companies within the same group or any organisation professionally involved with this promotion (or in each case, their close relatives), are not eligible to enter. An entrant may only be entered into the prize draw once.

How to enter:

3. On 20th July 2026 Jet2 will make a post on Facebook (@Jet2) relating to this Prize Draw with instructions of how to enter. To enter this prize draw you must follow these instructions, which will include commenting on the post with a public Facebook account between the opening and closing times and dates detailed in paragraph 1 above.
4. Jet2holidays shall not be responsible for and shall not have to accept entries which do not reach it before the closing time or are illegible, incomplete or corrupted.

Choosing a Winner:

5. There will be 1 lucky first-place winner of the main prize draw and 2 runners-up (together, the "winners").

Winners must have a valid email address to claim their prize.

9. For transparency we will generally publish the surname and county of prize winners online. However, if you are a winner and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize.

The Prizes:

10. The first-place winner will win:
