

Terms & Conditions – myJet2Perks x Freixenet Prize Draw

This prize draw is promoted by Jet2.com Limited (registered number: 02739537) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2.com", "Jet2" "us" or "we"). By entering this prize draw, you are deemed to accept these terms.

1. This prize draw opens at 09:00am on 7th August 2025 and closes at 11:59pm on 21st August 2025.
2. Entrants to this prize draw must be myJet2 members logged into myJet2 on the Jet2 app, residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays Limited, Jet2.com Limited, Jet2 plc, employees and officers of Freixenet Copestick or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter. An entrant may only be entered into the prize draw once.

How to enter:

3. Jet2 will host a landing page in the Jet2 app.
4. To enter this prize draw you must log onto myJet2 within the Jet2 app and click to enter the prize draw by following the relevant URL and enter your details before the closing time and date detailed in paragraph 1 above.
5. Jet2 shall not be responsible for and shall not have to accept entries which do not reach it before the closing time or are illegible, incomplete or corrupted.

Choosing a Winner:

8. We will try our best to contact the winners during the specified time. If a winner cannot be contacted or is not available, we reserve the right to select another winner from the valid/correct entries that were received.
9. The winners will be required to confirm acceptance of their prize and provide their full name, contact number & delivery address within 7 days of having been notified by the Company.
10. When the time limit of 7 days to claim their prize has passed, the Company will then submit an internal samples request (required to get the stock delivered) with all of the winners who have claimed their prize to fulfil the cases of wine. The allocation of Prosecco & Italian Sparkling Rose will be allocated on a random basis unless preference stated by the winner.
11. Winners must have claimed their prize no later than Friday 5th September 2025. If a winner has not claimed their prize by the date specified, we reserve the right to select another winner from the valid/correct entries that were received. Winners must have a valid email address to claim their prize.
12. The Company will organise 1 x delivery and 1 x re-delivery but if the prize is not successfully delivered after this, it will be returned to the warehouse.
13. For transparency we will generally publish the surname and county of prize winners online. However, if you are a winner and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize.

Prize Terms:

19. Jet2 reserves the right (but shall be under no obligation) to substitute the prize or any element of the prize with an alternative at any time to the equivalent prize value or at its discretion, the cash value of the prize or element of the prize being substituted.

General Terms:

25. Where Jet2 makes any changes to the prize, no compensation or cash equivalent will be available. Jet2 will not be liable for any cancellations or changes to the prize draw or any prize, or for any loss or damage. Nothing in these terms shall exclude or limit the liability of Jet2 in relation to personal injury or death caused by Jet2 negligence or for fraud.
