

### **Terms & Conditions – myJet2Perks x M&B Prize Draws**

These prize draws are promoted by Jet2.com Limited (registered number: 02739537) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2.com", "Jet2" "us" or "we"). By entering a prize draw, you are deemed to accept these terms.

1. There will be 3 (three) prize draws in total:

(a) Prize Draw 1 opens at 09:00am on 1st May 2025 and closes at 11:59pm on 29<sup>th</sup> May 2025.

(b) Prize Draw 2 opens at 11:59pm on 29<sup>th</sup> May 2025 and closes at 11:59pm on 26<sup>th</sup> June 2025.

(c) Prize Draw 3 opens at 11:59pm on 26<sup>th</sup> June 2025 and closes at 11:59pm on 31st July 2025.

2. Entrants to each prize draw must be myJet2 members logged into myJet2 on the Jet2 app, residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over.
